A student cannot be considered independent solely because a parent refuses to provide information on the FAFSA or does not support the student financially.

You must have a current 2021-2022 FAFSA on file at CCD. Submit the FAFSA providing only your information. Your FAFSA will be rejected because it is missing parental information. If this Petition is approved, the Financial Aid Office will process your FAFSA. If this Petition is denied, you will need to add parental information to the FAFSA or you may speak with a Financial Aid Advisor to discuss your options. If you are unable to provide the required information to complete your FAFSA, you may be required to cover your educational costs without the benefit of financial aid.

All Petitioners must complete this form in its entirety and provide the following:

1. Completed 2021-2022 Verification Worksheet – Dependent Student Form 1. Leave parent information blank at this time. If your Petition is denied, we may request that you add parental information to the form. All student forms are available online at [www.ccd.edu/studentforms](http://www.ccd.edu/studentforms).
2. You must submit your 2019 signed taxes if you were unable to use the IRS Data Retrieval Tool. A verification of non-filer letter from the IRS is needed if taxes weren't filed. If you earned wages you must submit all 2019 W2's.

Fully understanding your situation will help our office determine your dependency status so please provide as much information as possible. If you are petitioning because one or both of your parents are deceased, you must include copies of death certificates.
  2. A signed, detailed statement from an unbiased third party who is personally familiar with your family circumstances. This statement must support your appeal and the reasons you are unable to get parental information. Examples of an acceptable third party include: case manager, social worker, school counselor, teacher, police report, court documentation or another unbiased source that is personally aware of your situation. Your third party's statement should be signed and dated on official letterhead with contact information. Your third party must address the situation with both of your biological or adoptive parents. Please do not submit letters from family members or friends.
