MLA CITATION GUIDE (9th ed.)

Crediting your sources shows your research ethos and helps you avoid plagiarism. Include both **In-Text citations** and a **Works Cited** page to give proper credit.

In-Text Citations

In-text citations for direct quotes fewer than 4 lines are formatted using author-page style:

Narrative or Parenthetical Citation Example

According to Jones, "People often..." (24). [Narrative citation has the author's last name in the sentence.]

As a study showed, "People often..." (Jones 24). [Parenthetical citation has info in parentheses.]

Direct Quotes Citation Example

(include author last name and page number)

Direct quotes 4 lines or shorter are placed on the same line as your regular text, have quotation marks around them, and end with a period *after* the citation.

Direct quotes longer than 4 lines should appear in block format. The block quotation starts on a new line, is indented at 0.5 from left margin, does not use quotation marks, and ends with the period *before* the citation.

Page Numbers Citation Example

(include author last name and page number)

Direct quotes **must** have page numbers (no "p." or "pp." required):

Human beings have been described as "symbol-using animals" (Burke 3).

Wordsworth stated that Romantic poetry was marked by a "spontaneous overflow of powerful feelings" (264).

Multiple Authors Citation Example

How to cite sources with multiple authors

2 authors (in-text): cite both authors at all times. Use "and" both in-text and in parentheses.

Smith and Jones found that ... (12). The researchers found that ... (Smith and Jones 12).

MLA Citation Guide (9th edition)

3 or more authors (in-text): use only the first author's name and "et al." for the rest.

Smith et al. discovered that ... (12). The researchers discovered that ... (Smith et al. 12).

Secondary Sources Citation Example

Secondary/indirect citations of sources (a source within a source)

Reference the original author in the sentence, and use "qtd. in" plus the source you found the information in, within the parentheses:

Ravitch argues that high schools are pressured to act as "social service centers, and they don't do that well" (qtd. in Weisman 259).

The following shows how a properly formatted **Works Cited** page—with examples of different kinds of sources—should look.

Book

One author:

Mantle, Hilary. Wolf Hall. Picador Press, 2010.

Two authors:

Gillespie, Paula, and Neal Lerner. The Allyn and Bacon Guide to Peer Tutoring. Penguin, 2000.

Three or more authors:

Wysocki, Ann, et al. Writing New Media: Theory and Applications for Expanding the Teaching of Composition. Utah State UP, 2004.
