**Spring 2026**

**Bill History**

**WHEREAS**, the Student Advisory Committee to the Auraria Board (SACAB) represents students from all three institutions on the Auraria Campus and serves to elevate and advocate for the student voice;

**WHEREAS**, Senate Bill 26034, the Auraria Board Student & Faculty Participation Act, became Colorado law on March 21, 2026, granting SACAB a formal voting seat on the Auraria Board of Directors and reducing barriers to participation;

**WHEREAS**, this legislative change represents a significant advancement in shared governance and student representation across the Auraria Campus;

**WHEREAS**, the University of Colorado Denver Student Government Association is leading the planning of a tri-institutional celebration in the Tivoli Student Union to commemorate SACAB’s new voting rights and the passage of the bill;

**WHEREAS**, SACAB has formally resolved to support this celebration and has recommended that each of the three institutions—including the Community College of Denver—contribute funds toward its success;

**WHEREAS**, the Community College of Denver Student Government Association (CCD SGA) has the authority to allocate funds from its General/Operating Budget to support student centered initiatives and interinstitutional programming;

**THEREFORE BE IT ENACTED** by the Student Government Association of the Community College of Denver, AS FOLLOWS;

**Section 1: Appropriation of Funds**

1. CCD SGA authorizes the allocation of \$1500 from the CCD SGA General/Operating Budget in support of the tri-institutional celebration recognizing SACAB's newly established voting rights and the passage of Senate Bill 26-034. Below are potential expenses associated with the event.
  - Space Reservation: \$310
  - Catering: \$1500-\$2000
  - Decor: \$300-\$500
  - Memento Lego Tivoli (hopefully covered by AHEC):
    - 100 - \$12.75 (each)
    - 250 - \$10.40 (each)
    - 300 - \$9.80 (each)
    - 350 - \$9.50 (each)
    - 500 - \$8.95 (each)
    - 750 - \$8.25 (each)
    - 1,000 - \$7.95 (each)

**Section 2: Oversight and Use of Funds**

1. The CCD SGA Treasurer, in coordination with SGA Advisors, the CU Denver Student Government Association, and SACAB, shall oversee the disbursement and tracking of allocated funds.
2. All expenditures must comply with CCD financial policies, campus procurement procedures, and SGA governing documents.
3. Any unused portion of the \$1500 allocation shall revert back to the CCD SGA General/Operating Budget at the conclusion of the Spring 2026 semester.

**Section 3: Collaboration & Representation**

1. CCD SGA shall collaborate with SACAB and the Student Governments of the University of Colorado Denver and Metropolitan State University of Denver to ensure coordinated planning, equitable cost sharing, and meaningful representation of CCD students during the celebration
